1. Course registration will close one week (five business days) prior to the course date.
2. Payment must be made in full prior to the class in order to be considered registered for it. Payment can be made by credit card, cash or cheque. Members in good standing can continue to be invoiced for courses; however, the cancellation policy will still apply.
3. All cancellations must be received by the MTA office, either in writing or by phone, one week (five business days) prior to the course date in order to receive a full refund.
4. Any cancellations that occur within one week (five business days) of the course date are subject to a 50% cancellation fee.
5. Any cancellations that occur within 48 hours (two business days) of the course date are subject to a 100% cancellation fee.

Driver's Abstract	<ul style="list-style-type: none"><li><input type="checkbox"/> Must not have more than four demerit points on driving record</li><li><input type="checkbox"/> During the 3 years immediately preceding the date of application, must not have had more than two violations of the Highway Traffic Act, National Safety Code, or TDG Regulations. This includes violations under any similar Act or Regulations in any other North American jurisdiction.</li><li><input type="checkbox"/> During the 3 years immediately preceding the date of application, must not have had more than two reportable at-fault accidents. This includes reportable at-fault accidents in any other North American jurisdiction.</li><li><input type="checkbox"/> During the 5 years immediately preceding the date of application, must not have had more than two unpardoned convictions under the Criminal Code of Canada by means of a motor vehicle or while driving or having care and control of a motor vehicle.</li><li><input type="checkbox"/> During the 5 years immediately preceding the date of application, must not have had any unpardoned convictions of an offence against a person or a sexual offence under the Criminal Code of Canada, or any contravention of the Human Rights Code or the Human Rights Act of Canada or of any Province of Canada.</li></ul>
